A Within-Country Study of Biased Comparative Judgements About the Severity of Environmental Problems

We report detailed results for the measurement invariance analysis for the state and Brazil scales below. States with significant noninvariant measurement parameters are in boldface in parentheses. As noted in the main article, only 1% (four out of 378) parameters are non-invariant for the state scale (see Table S1), while all loadings and intercepts were invariant for the Brazil scale (see Table S2).
