Dear reader,

This study is part of the meta-scientific research that is currently underway at the **Leibniz Institute for Psychology (ZPID)**. We are an open science institute located in Germany, and we strive to support researchers in psychology and related fields by providing an excellent (digital) infrastructure adapted to their needs.

With this study, we want to test the usability of a recently published preregistration template, the **Psychological Research Preregistration-Quantitative (PRP-QUANT) Template**, which was created by a task force consisting of members of the **German Psychological Society (DGPs)**, the **American Psychological Association (APA)**, the **British Psychological Society (BPS)**, the **Center for Open Science (COS)**, and the **Leibniz Institute for Psychology (ZPID)**.

A preregistration is a study plan that is registered with an independent party (e.g., a repository) before the data has been collected or examined. Upon registration, a time-stamped record of the study plan is created that will eventually be published (possibly after an embargo period). If the study plan changes afterwards, either a new record needs to be created or the deviations will be apparent when comparing the preregistration to the final manuscript. Thus, preregistration allows a transparent presentation of what was planned at a certain time point and what changes may have been made to a study until its publication.

The present preregistration template was created to help you create such preregistrations by providing a form that includes the most important information to preregister which can be filled in. It is tailored to the field of psychology, focusing on quantitative research.

Your feedback will help us to understand whether the template is written clearly and whether it helps you to plan your study by capturing the important aspects of your research. Therefore, your participation would be extremely valuable as results will be used to adapt the template as well as ZPID's preregistration service. The study takes about 30 to 45 minutes to complete.

Participant Information and Informed Consent

Overall information: We invite you to participate in our study, which serves as a usability study for a new preregistration template. Your participation in this study is voluntary. You may choose not to participate. The purpose of this form is to provide you with all information necessary to decide if you want to participate. Please read it carefully. If you have any questions that are not answered by this form, please do not hesitate to contact us (see below).

Aim of this study: This study was designed to test the usability of a new preregistration template which was created by a task force consisting of members of the German Psychological Society (DGPs), the American Psychological Association (APA), the British Psychological Society (BPS), the Center for Open Science (COS), and the Leibniz Institute for Psychology (ZPID).

Procedure: In the following, we will show you the new preregistration template. You will be asked to fill out a subset of the template's items, as well as evaluate single items and the overall template. Additionally, you will be asked to answer a short questionnaire. Response formats for the items include rating scales, single or multiple choice, or open text input. The study will take about 30-45 minutes to complete. Participants that do not belong to the target sample will be excluded at the beginning of the study.

Collection and processing of personal information: We collect data on gender, age, native language, country, academic group, research topic, and membership in a psychological society. Based on these data, it will not be possible to identify specific persons. Your email address (optional for receiving further information) is collected separately, i.e., it is not possible for us to link it in any way to your responses in the study. Furthermore, we do not collect other identifying information such as your name or IP address. Anonymity is therefore maintained.

Possible risks: No known risks are associated with participation in this study.

Withdraw participation: Participation is voluntary. You have the right to refuse participation and withdraw at any time without any consequence whatsoever and without stating any reasons for doing so.

Data processing and usage of anonymized data: Anonymity of your responses is preserved, and no individual association will be possible, as email addresses will be collected separately. Your data will be processed in agreement with the legal provisions of the European law (General Data Protection Regulation, more information is available here: <https://gdpr.eu/tag/gdpr/>). The results of our study will presumably be published as a scientific research article. Furthermore, the anonymized data will be made publicly available in line with transparent and open research practices, as recommended by the German Research Foundation (DFG) and the German Psychological Society (DGPs).
